### **Sub: Redevelopment Working Committee (RWC) of the Society**

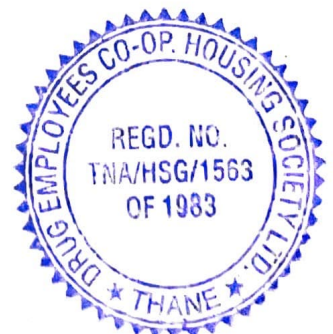

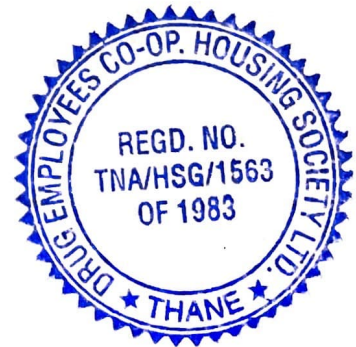
In addition to this, any member of the Managing Committee (M.C), upon completion of term/resignation may be inducted by virtue of voluntary participation to the RWC.
